CUSTOMER SERVICE AGREEMENT

Sewer

I. PURPOSE.

Kendall County WCID #1 is responsible for the treatment of sewage that enters the sanitary sewer system owned by the District. The purpose of this service agreement is to notify each customer of the regulations which are in place to provide and continue this service. The utility enforces these restrictions to ensure public health and welfare. Each customer must sign this agreement before the Kendall County WCID #1 will begin service. In addition, when service to an existing connection has been suspended or terminated, the water system will not re-establish service unless it has a signed copy of this agreement.

II. APPLICATION.

A written application shall be submitted for the connection of a sewage service line to each premises or group of premises where an individual service line connection is permitted. The application shall be subject to such sewage service fees and rates currently prevailing, and as hereafter revised. The application and the rules and regulations of the Kendall County WCID #1 shall regulate the sewage service to such premises, as those rules and regulations may be currently in effect and as may be adopted, amended, or superseded.

Applicant grants Kendall County WCID #1, its employees and authorized contractors, a right of entry upon the Applicant's property where the service is provided for the purpose of inspecting the construction, condition, and repair of the sewage plumbing for compliance with applicable rules and regulations.

The application for sewage service shall be a binding contract on both the customer and the Kendall County WCID #1, after approval. Venue for any claim or suit relating to this service agreement or service to the applicant's property shall be in Kendall County, Texas.

A new application must be submitted upon any change in ownership, tenancy, or in service of premises as described in the application. The Kendall County WCID #1 shall have the right, upon 10 day's notice, to discontinue service until such new application has been made and approved.

III. BILLING

The rates for service shall accrue from the date the sewage service is available to the premises.

All bills are payable by mail, in person, or drop off at the Kendall County WCID #1 office in Comfort, Texas.

Billing is issued on the first of each month and due payable by the fifteenth of each month.

Payments made after the fifteenth of each month (late payment) are subject to a late payment charge, currently equal to ten percent (10%).

IV SERVICE OF NOTICES

All notices and bills relating to the Kendall County WCID #1 or its business shall be deemed to have been properly serviced if mailed to the customer, if left upon the premises of the customer, or serviced in person at the address as shown on the records of the Kendall County WCID #1.

The Kendall County WCID #1 will service all notices and bills to the address given on the application for service until a notice of change, in writing, by telephone, fax or e-mail has been filed with the Kendall County WCID #1, and acknowledgement of receipt of said notice has been determined.

V NONPAYMENT

Nonpayment of billed services will be subject to termination (disconnection) of service after thirty days. Sewage service which has been terminated due to nonpayment will be subject to a reconnect service fee.

VI SERVICE AGREEMENT

The Kendall County WCID #1 will maintain a copy of this agreement as long as the customer and/or the premises are connected to the Sewage System.
